## INVESTMENT CATEGORIES

All social membership categories includes use of dining facilities, but does not include golf; quarterly minimums do not include alcoholic beverages, service charge or sales tax.

**Social**~ Individual or Family Social Membership

- \$100 yearly; Due with application
- Renewable on anniversary date
- Food minimum spending \$25.00 quarterly

**Small Business**~Membership for employers with less than (10) ten employees

- \$250 yearly; \$100 due with application
- Remaining \$150 billed quarterly at \$50 per quarter
- Allows for one business holder and up to (3) three additional riders for a total of (4) four persons.
- Renewable on anniversary date with quarterly billing then being \$62.50 unless paid in full upon renewal
- Food minimum spending \$25.00 quarterly

**Corporate**~Membership with more than (10) employees

- \$500 yearly
- \$125 due with application
- \$125 billed quarterly
- Allows for one corporate holder and up to (6) six additional riders for a total of (7) seven persons.
- Additional riders may be added for additional \$25.00 per quarter per person.
- New riders will be billed a one time initiation fee of \$25 plus the pro-rated quarterly dues (if applicable) upon Board approval of membership
- Renewable on Anniversary date
- Food minimum spending \$50.00 quarterly

*All dining charges will be billed on a monthly basis and mailed for payment.  
Currently, we can only accept payment via check or cash.  
The Pro Shop accepts credit cards.. Fee schedule subject to change.*
